POINT FOUNDATION CURRENTLY AWARDS TWO TYPES OF SCHOLARSHIPS: COMMUNITY COLLEGE AND THE TRADITIONAL POINT SCHOLARSHIP. THE COMMUNITY COLLEGE SCHOLARSHIP IS GEARED TOWARD ENSURING LGBTQ COMMUNITY COLLEGE STUDENTS ARE ABLE TO TRANSFER TO FOUR-YEAR INSTITUTIONS. THE TRADITIONAL POINT SCHOLARSHIP IS DESIGNED TO HELP LGBTQ SCHOLARS CURRENTLY ENROLLED IN OR ENROLLING IN AN UNDERGRADUATE OR GRADUATE PROGRAM COMPLETE THEIR DEGREE. BOTH SCHOLARSHIP PROGRAMS OFFER FINANCIAL ASSISTANCE, ONE-ON-ONE MENTORING (COACHING) AND COMPREHENSIVE LEADERSHIP TRAINING.
